IP News

In order to advance the IP Urban Trans research with regard to POF IV towards "Urban Resilience" we conducted an UFZ-wide query. In February/March 2019 we asked all researchers at the UFZ to send us a short feedback if they have been/are working on the issues "resilience", "urban resilience" or "resilient cities". So far, more than 30 researchers from all research units have shown their

> Free Online Webinars of the German-US Network "Zukunftsstadt - Future City": The network facilitates the exchange of ideas as well as the access to expert knowledge and markets in Germany and the USA. Recordings are available for most of the so far 8 webinars, e.g. Tamar Shapirs webinar on "Assessing Transatlantic Exchange on Urban Revitalization", Stephan Bartke on "The Role of Stigma in Land Re-Use" and Reimund Schwarze, Oleksandr Sushchenko and Hannes Rassmann on "Global Warming: What can we learn from the COP24 meeting?"

Call for papers for Special Issue Sustainability "Urban Transformations Towards Sustainability" extended until June 30th, 2019: It will portray comprehensive inter- and transdisciplinary research on urban transformations towards sustainability and depict outstanding research in order to provide stakeholders with robust knowledge. Guest editor: Sigrun Kabisch.

WP 2 - Urban Land Use, Urban Ecosystem Services: After 9 years of work the long-term Urban Forests project was successfully completed with a conference in October 2018. The results were presented to the scientific community as well as representatives from other municipalities and are documented in a manual for planning practice. After two years, the EU funded project EnRoute, a science-policy project focusing on the role and benefits of green infrastructure in European cities, ended early 2019 with a Final Conference in Brussels in partnership with the European Committee of the Regions (CoR). This project consisted of



18 European city-labs, including the Leipzig city-lab with the UFZ and Leipzig City Council, Department Urban Green Areas and Watercourses. Within the BiodivERsA project UrbanGaia, a networking event took place, again with Department Urban Green Areas and Watercourses. Essential project results about the use of ESS in urban parks and brownfields in Leipzig were presented. New project: Funding is approved for the 4-year-EU project REGREEN which will be launched in September 2019 and includes collaboration with Chinese cities.

Lecture Series Children's Environmental Health in Urban Context: Since December 2018 up to now, we were very happy to welcome four international experts from the field of interdisciplinary health research in urban context. The lectures gave valuable insights into inter- and transdisciplinary responses to urban health challenges (Roderick Lawrence), the early life exposome assessment (Mark Nieuwenhuijsen), the Time-Geographic Framework as a systems approach by Martin Dijst and the empirical application of the Urban Exposome Framework by Konstantinos Makris. The lectures



presented a variety of scientific perspectives and were followed by lively discussions. The lecture series as a joint activity between the RU Environment and Society and the RU Chemicals in the Environment is part of the preparations to apply for a Competence Center on Children's Health with focus on environmental context together with the Children's Hospital of the University of Leipzig.

Joint lecture on **"Developing and managing urban ecosystems – challenges and opportunities for childhood health"** on **April 10th 2019** from 1-3pm (KUBUS, Lecture hall 1A): For the 4th lecture within the series "Children's Environmental Health in Urban Context", we will welcome **Prof. Dr. Matilda van den Bosch** from the School of Population and Public Health at University of British Columbia (Canada) and **Dr. Nadja Kabisch** from the Institute of Geography at the Humboldt-University Berlin.



International Conferences



From November 25th -27th 2018, **Maximilian Ueberham** and **Juliane Schicketanz** attended the first Urban Transitions conference in Sitges, Barcelona, Spain. The conference focused on integrating urban and transport planning, environment and health for healthier urban living. Maximilian Ueberham presented his research on smart sensing of multiple environmental stressors and individual perception and Juliane Schicketanz discussed her and Miriam Brencks work on social factors affecting children's health in urban areas. Both highly appreciated the feedback received and the constructive atmosphere.

Upcoming: Natalie Jean-Baptiste and Reimund Schwarze will participate at the **ECCA 2019** - 4th European Climate Change Adaptation conference "Working together to

prepare for change" from May 28–31 2019 in Lisbon. Together with Chantal Pacteau (France), Mattia Leone (Italy) and Luc Abbadie (France), they organise the session "Climate Change and Cities: Second Assessment Report of the Urban Climate Change Research Network" oriented to disseminate the key messages from the Urban Climate Change Research Network's Second Assessment Report on Climate Change in Cities (ARC3.2)

Urban Climate Change Research Network's Second Assessment Report on Climate Change in Cities (ARC3.2) and discuss potential pathways for their implementation. **Reimund Schwarze** will speak on "Financing Climate Change Solutions in Cities", while **Natalie Jean-Baptiste** will talk about "Housing and Low-Income Communities".
